2. Ramp/Rails:

Parking for people with disabilities is available near the building. This is easily accessible to cross-disability groups equally. The doors should be wide enough to accommodate wheelchair users and the space inside is sufficient for them. Appropriate heights control panels and the large buttons are embossed.




